  - Change of stream
  - Change of residential address (Document required: Residence Proof)
  - Change of Board
- All admissions are done solely on the basis of merit irrespective of their category.
- For preparing the merit list, the criterion will be -the average percentage of marks obtained in X std. and XI std.
- · Offering of a Second language & Maths depends on the availability of the

seats & Maths Marks of X std. resp.
