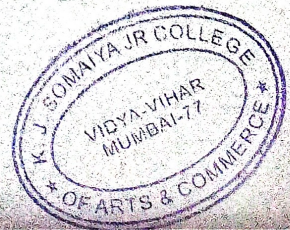

- The following documents should be produced along with the duly filled admission form copies (2 sets of each document) at the time of verification.
 - Printed copy of Admission form with passport size photograph
 - Original Leaving Certificate/No objection certificate from the previous institution
 - Students from other than Maharashtra State Board should bring their Eligibility Certificate received from their previous college or copy of the acknowledgement of their application submitted to the Vashi Board for the same.
 - Original Mark-sheet along with two attested copies of the SSC and FYJC class
 - Letter from parent stating reason for change in Institution
 - Undertaking from the student
 - Ration Card Xerox (First and Last page) for girl students
 - Aadhar card copy
 - Caste Certificate - Original & attested Xerox)

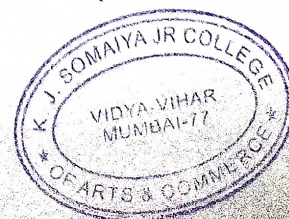

Admission Criteria:

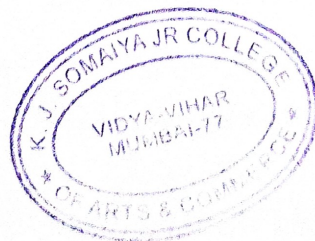
Please Note:

- The External admissions for SYJC students will be considered only for the following reasons:
 - Distance from existing Institution (Document required: Residence Proof)
 - Transfer of parent (Document required: Company's Letter of transfer)
 - Medical grounds (Document required: Medical Certificate)
 - Change of stream
 - Change of residential address (Document required: Residence Proof)
- All admissions are done solely on the basis of merit irrespective of their category.



- For preparing the merit list, the criterion will be -the average percentage of marks obtained in X std. and XI std.
- Offering of a Second language & Maths depends on the availability of the seats & Maths Marks of X std. resp.
- **The College will not be responsible if a student cancels his/her admission in his/her college without confirming his/her name in the merit list / without securing admission by paying fees within the stipulated days/period indicated in the merit list.**
- A student must submit LC/NOC (No objection Certificate) from his/her last College attended at the time of securing admission, failing which admission will be denied (Only for Campus Junior Colleges)
- Candidates must carry one copy of the printed Acknowledgement Slip.
